The multinational lubricants company is based in the UAE and is a part of a global conglomerate. The company produces a comprehensive range of automotive and industrial lubricants.

In addition to supplying to B2B customers in the industrial, mining, infrastructure and fleet sectors, the company also distributes its products in the Middle-East, Levant, CIS regions, across 20 countries including Afghanistan and Pakistan, through a network of distributors.

The company also supplies to other entities within the global conglomerate around the world.

The company operates two state-of-the-art lubricant blending plants in UAE, with a combined blending capacity of nearly 150,000 tons per annum. One of the plants also has a grease blending facility. COMPANY OVERVIEW

The Industry

The Middle-East lubricants market is fragmented, with almost all global companies present in the region.

Economic growth in Iran, Saudi Arabia, UAE and Iraq accounts for nearly 70% of the consumption, with the rest of the Middle-East accounting for 30%.

While the Middle-East lubricants market is relatively young in comparison with other global industry markets, it is experiencing significant, ongoing growth. In fact, this market alone is expected to grow by 2% between 2019 and 2024, and by 6.5% between 2019 and 2026.



The Problems and Challenges

The company and the market for lubricants has been steadily growing in the last several years despite the volatile oil prices owing to the increase in automotive sales and industrial growth in a few countries.

The legacy software application had limited functionality and several critical business processes were managed on spreadsheets, resulting in:

- Inability to manage operations of multiple organizations on a single ERP application
- Inability to obtain consolidated financial reporting
- 3) Inability to manage multiple-currency transactions

- 4) Inability to accurately capture product costs, both, of products procured and produced
- 5) Onerous manual processes to monitor and control costs
- 6) Inability to comprehensively plan procurement and production based on forecasts
- 7) Inability to effectively manage product bills of materials, resulting in variations in inventory, erroneous inventory valuation and onerous stock reconciliation
- 8) Inability to manage taxation and regulatory compliance
